

MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE (DDC) MEETING HELD ON 4TH NOVEMBER' 2022 AT 12.00 P.M IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER, KARIMGANJ.

Members present - As per Annexure -"A"

The meeting was chaired by Sri Mridul Yadav, IAS, Deputy Commissioner, Karimganj. At the outset he welcomed all the members present in the meeting.

Thereafter, reviewed and discussion was held department wise which were recorded as follows-

Department	Decision taken	Action to be taken by
P&RD	<p>MGNREGA :</p> <p>a) In Patherkandi Dev. Block, wages generation is very poor in comparison to other Blocks. It was suggested to take up nurseries schemes in Forest Lands so that these can be shifted for plantation in various areas during planting season. The DFO, Karimganj was requested to extend necessary help to select land for the purpose.</p> <p>b) As regards inactive Job Cards, the CEO, ZP, Karimganj was requested to take necessary steps to cancel the same if the necessary documents are not submitted by the beneficiaries.</p> <p>c) The CEO, ZP, Karimganj was requested to take up materials oriented schemes like AWC, market sheds for SHGs, Roads etc. according to priority.</p> <p>d) Regarding achievement of target within the schedule time, the CEO, ZP, Karimganj was requested to ensure completion of each & every schemes within the allotted time period so that new schemes may be taken up for the benefit of the public as well as development of the district.</p> <p>PMAY (G) :</p> <p>a) The Block wise performance was reviewed and it is found that the completion of old PWL (Permanent Wait List) is being delayed against Patherkandi Development Block the chairman expressed his dissatisfaction on the matter. The CEO, ZP was requested to look into the matter personally.</p> <p>b) A discussion was held in respect of land for landless beneficiaries, it was decided that the land for the same to be arranged shortly from the part of the District Administration.</p> <p>c) The CEO was requested to ensure generation of 95 days wages to every beneficiary for those who have no any gap or break.</p> <p>NSAP: It was decided to organize camp for awareness in different areas covering all the Dev. Blocks, so that genuine beneficiaries may be able to get the benefit in a convenient manner.</p> <p>15th FC: It is reflected from the report that 4 (four) installments of fund for the year 2020-21 and 2021-22 is lying unutilized in the GPs account since long in spite of repeated pressure from the Govt., the fund has not been utilized. The CEO, ZP was requested to monitor the performance of the GPs officials prior to payment of their next salaries.</p>	CEO, ZP, Karimganj/ DFO, Karimganj
Forest (T)	<p>a) As regard construction of PMAY (G) in the forest land, the DFO was requested to held-up the construction of houses in the forest land which has already been communicated. In this respect, the DC requested the CEO to take right steps on the matter to avoid further complicity.</p> <p>b) Regarding deduction and deposit of Forest Royalty against the construction of work executed by the different Deptts. The DFO requested all the deptts concerns to deduct the same as per Govt. rate and deposit the same in time. The DC requested all the heads of the concern Depts. this may be abide by accordingly.</p>	CEO, ZP, Karimganj All Heads of Depts.
Water Resources	<p>a) It was reflected from the report that 5 nos. of old schemes are still ongoing, the Chairman expressed his dissatisfaction on the matter and viewed that the completion time should not be delayed and instructed the Executive Engineer to complete the schemes by December 2022 positively.</p> <p>b) As regards construction of embankment from Lowairpoa to Baithakhal on the bank of river Longai, the Executive Engineer appraised that the work is delayed due to land acquisition process. He was instructed to take up the matter with ADC (Rev.) and Circle Officer of concern Revenue Circle for early execution of the scheme.</p>	ADC (Rev.)/E.E, Water Resources, Kxj

Irrigation	It is reflected from the report that the Deptt. could not complete the work of old projects under PMKSY/AIBP which indicates the negligence of the officials for performing duties. The DC instructed the EE to make special counseling with the DDC to resolve all the facts and issues which are hindrance to progress the work and complete the same within the committed period by December 2022. Health	<p>a) It is pointed out in the meeting about the public complaint on negligence of attending serious patients rather than referred to SMCH. In this connection, the DPM, NHM appraised the house that the matter has been taken seriously and such incidences have been reduced to considerable extent at present.</p> <p>b) The Deputy Commissioner expressed dissatisfaction on the activities/performance of PHCs and CHCs in the district especially in the remote areas. It is decided that the Joint Director, Health Services/ SDMO concerned should regularly visit the same and monitor the performance to ensure proper functioning of the PHCs and CHCs.</p> <p>c) A discussion was held regarding construction of boundary walls of Bidyanagar, Chargola and Cheragi PHC. It is decided that these may be taken up under any admissible source of fund.</p>	Jt. Director, Health Services, Kxj DDC/C.E.O Zila Parishad
Soil Conservation	As regards the scheme Nilambazar Erosion Control Project, the D.O appraised that the work of the same will be completed shortly. The Deputy Commissioner desires to visit the scheme and the D.O was instructed to fix a date for the purpose. Regarding land development project at vill. Medha-II, the D.O appraised that the work of the same will be started shortly in a ceremonial layout.	D.O, Soil Conservation, Kxj
PWD Roads	<p>(North, South, Badarpur Division)</p> <p>a) Regarding Asom Mala, the E.E appraised that land acquisition compensation to be disbursed within 3 months.</p> <p>b) It was observed from the report that a few schemes under PMSGY-III (2020-21), RIDF (2021-22), Asom Darshan (2019-20), and BADP (2019-20) are yet to be completed. The Deputy Commissioner instructed the E.E to complete the same immediately as these are long pending schemes.</p> <p>c) Regarding the execution of work Mokoil Bhangra to Adarkona road which is yet to be completed. The Deputy Commissioner instructed the E.E to appraise in black and white the reason for delay in execution of the work by the contractor and if any, action taken against the contractor concerned.</p> <p>(Patharkandi & Ratabari Division)</p> <p>a) It is reflected from the report that no work against the programme BADP (2017-18), Asom Darshan (2019-20), SOPD (2020-21), RIDF (2020-21) has been completed. The Deputy Commissioner expressed his dissatisfaction on the matter and instructed the E.E to appraise the reason for non-completion of the work.</p> <p>b) As regards construction of RCC Bridge over river Singla at Cheragi Bazar under RIDF (2019-20). The Deputy Commissioner instructed the E.E to complete the same early.</p> <p>Further, the Deputy Commissioner instructed both the Executive Engineers of the division to execute the work of any bridge and road by providing a service road so that the general public does not have any inconvenience.</p>	EE of both the Div.
National Highway	The E.E (N.H) Kxj was appraised that the Hon'ble. M.P Karimganj will visit the work carried out by the deptt. shortly. He was instructed to keep updating the position of work.	E.E (NH), Kxj.
Fisheries	<p>a) It is reflected from the report that the performance against the disbursement of benefit to the beneficiaries' oriented schemes is poor. The DFDO, Kxj was instructed to complete the same in a mission mode through organizing a camp in maximum beneficiary oriented areas.</p> <p>b) Regarding achievement against KCC for the year 2020-21 is found very poor, i.e., out of 1624 nos. sponsored 123 nos. sanctioned by the bank. The department was instructed to take up the matter with the LDM.</p> <p>In this connection, the Deputy Commissioner instructed all the departments concerned related to bank oriented schemes to forward the proposals to the bank branches through LDM with a copy to District administration.</p>	LDM / DFDO, Kxj./ D.O., Agriculture / G.M, DICC
Agriculture	<p>a) As per report of the Deptt. it is found that some equipment/ machineries are yet to be disbursed. The officials present in the meeting appraised that some beneficiaries are reluctant to receive the same as the subsidy rate is very low.</p> <p>b) Regarding distribution of Seed and components distribution, the Deputy Commissioner instructed the D.A.O to disburse the same in a transparent manner through ceremonial arrangement in the presence of the District Administration and other public representatives.</p>	D.A.O, Kxj

DDC	It was observed from the report that out of 88 nos. of proposals against PMEGP, 21 nos. has been returned by the various bank branches. The Deputy Commissioner requested LDM to monitor and investigate the matter and take necessary steps for disbursement of the same.	LDM, Karimganj
PWD (Building)	The progress of various works of the departments was reviewed. The Deputy Commissioner instructed the E.E to complete the work of the scheme under CM's Spl. Package and the schemes under Cultural and Higher Education departments including the schemes against which electrification work yet to be done immediately. Further, in a query about the scheme Malegarh Tourist Complex, the E.E appraised that the work of the same is going on and will be completed within the scheduled time. Education	It is reported that land for 6 nos. of Model Anganwadi Centres could not be solved. The ADC (Edn.) was requested to discuss the matter with ADC (Rev.). Regarding amalgamation of AWCs with schools and main cluster have already been done.	ADC (Edu.) ADC (Rev.)
T&CP	The work under PMAY-Urban was reviewed in the meeting. The house suggested the department to take necessary steps for early completion of the same.	Dy. D, T&CP
Food and Civil Supply	Regarding Aadhar seeding for ration cards it was reported that, the same has already been done. It is also appraised the house that deleted households to be re-enrolled through new process.	ADC (F & CS)
PHE	a) The E.E appraised that no new pipeline connection to be provided to any schools and AWCs as per the direction of the higher authority. b) The Deputy Commissioner instructed the department to get all the plants and sources in order so that every beneficiary covered by the scheme should not be reduced and desired supply can be continued. c) The Deputy Commissioner instructed the E.E to blacklist the contractors against the work which are inadmissibly delayed by the contractor concerned and submit report to the District Administration. At the end, the Chairman requested all the departments to work sincerely so that the schemes taken by the Govt. for the welfare of the public may be completed in time.
