

MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE (DDC) MEETING HELD ON 8TH SEPTEMBER' 2022 AT 12.00 P.M IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER, KARIMGANJ.

Members present - As per Annexure -"A"

The meeting was chaired by Sri Vikram Dev Sharma, ACS, Dist. Dev. Commissioner, Karimganj. At the outset he welcomed all the members present in the meeting.

At the beginning, the data on DMI for the month of August '22 submitted by the department concerned was confirmed after discussion. Thereafter review and discussion was held on last DDC minutes which are recorded as follows--

1. Regarding 'Apke Dwar Ayushman' the department should fix timeline and make wide publicity of the same. It was also decided to convene a meeting shortly on the matter.

2. Mukhya Mantri Souro Shakti Prokolpo :-

Regarding establishment of another Floating Model the AGM reported that there is no scope to establish another model in the district and for Solar Power Generation. A team has already visited the district for establishment of the same.

3. Crop diversification :-

Regarding crop diversification all sort of possible action has already been taken and for establishment of pineapple processing unit a proposal has already been submitted. In this connection, the DAO was requested to keep touch with the D.I & C.C for establishment of such project.

Action- DAO, Agriculture, Kxj

4. Celebration of village foundation day:-

The CEO, Zilla Parishad, Karimganj appraised that the process are on for the same.

5. Adopt an Anganwadi by local colleges, Universities, renowned families etc. :-

A discussion was held on the matter and the DSWO was directed to prepare a list, entrusting one AWC to each department and submit the same to the Deputy Commissioner, Karimganj which to be notified from the part of district administration.

Action: 1.DSWO,Kxj

6. Sansad Khel Khud Spardha :-

Regarding Sansad Khel Khud Spardha, the District Sports Officer appraised that the action has already been initiated.

7. Transport :- Regarding problem of registration of E-rickshaw, the DTO informed that the registration has already been started as per departmental norms. He also appraised the annual target of revenue collection has been enhanced to Rs. 17.66 Cr. against 15Cr. Revenue collected in the month of Aug-2022 is Rs. 1,22,20,364 and cumulative is Rs 5,79,33,350.

8. **Zilla Parishad** :- (i) As regards, payments of power consumption bill water supply scheme to be paid by the Pani Samiti through Zilla Parishad the CEO, Zilla Parishad, Karimganj pointed out that the payment of the bill through Zilla Parishad has been entrusted from the month of July'22 but the APDCL authority have sent the bill including the amount prior to July-2022. In this connection the APDCL authority was instructed to re-submit the bill after segregating the amount as pointed and both the department including PHE were requested to sit in meeting to settle the issue. They have also been requested to take up the matter with their higher authority, if necessary.

(ii) A discussion was held in respect of "Development of public field with facility for emergency landing of three choppers under United Fund 2016-17, the site selected for the same is a low lying place and the C.E.O Zilla Parishad, Karimganj were requested earlier to make arrangement of earth filling from the fund under MGNREGA. The C.E.O Zilla Parishad, appraised that a scheme of earth filling was taken under MGNREGA two years back but due to non availability of soil nearby, the schemes could not be executed. It has also been reported that earth filling under MGNREGA will not be possible.

9. **Health** : As regards drives against Tobacco and selling of tobacco products near school and colleges, the ADC Magistracy was requested to take action immediately.

10. **APDCL** :- (i) The AGM APDCL reported that for set up a Sub -Station suitable land is available at Awlabari Tea Estate and the Manager agreed to provide the land. NOC to be collected shortly.

(ii) Regarding financial grant against death (3 nos.) caused by electrocution, the AGM reported that necessary fund has already been received and disbursement will be made shortly to the deceased family.

11. **D.I & C.C** :- As regards, benefit to all sponsored beneficiaries under PMEGP, The GM , DICC was instructed to take necessary steps for disbursement of loan to all sponsored beneficiaries by this month. He was further instructed to take help from the Lead District Manager, if necessary.

12. **PWRD** :- It is observed that no works against ongoing schemes have been started in both the division after flood . Both the Executive Engineer, PWRD appraised that mobilization is going on and work will be started shortly.

13. **PHE** :- Regarding construction of Community Latrine in each G.P under Swchha Bharat Abhijan, the C.E.O, Zilla Parishad, Karimganj reported that the location of 15 nos. of G.P has already been selected . She was requested to provide the list to Executive Engineer, P.H.E. The Executive Engineer, PHE was instructed to form the Pani Samiti against the remaining water supply schemes against which Samiti has not yet been formed.

14. **Irrigation** : Regarding installation of Solar electric tube well against which no progress has been made from last 2 months. The Executive Engineer, of both the division reported that they have taken utmost care to progress the work but the response from the contractor concerned is not satisfactory. They were instructed to take necessary steps against the contractors, if they are reluctant to complete the work.
15. **PWD(Bldg.)**: The Executive Engineer was instructed to submit the requisition against the schemes under Untied Fund by Sept '22. Regarding schemes under MSDP and CM package. It was reported that the work of the same will be completed by Sept.'22.
16. **Excise**: The Supdt. of Excise reported that the collection is as follows—
Revenue collected during the month of Aug-2022 is Rs.1,58,76,708.78 and cumulative is Rs. 9,22,86,772.91 against target Rs.29.12 Cr.
17. **Fishery**: The progress of different activities was reviewed. It is found that the achievement on Pradhan Manntri Matshya Sampad Yojana for the year 2021-22 is not satisfactory and KCC(Fishery) loan 2020-21 and 2022-23. The DFDO was instructed to gear up the work so that the schemes may be completed early.

At the end, the Chairman requested all the departments to work sincerely so that the schemes taken by the Govt. for the welfare of the public may be completed in time.

Then the meeting ended with vote of thanks from the Chair.
